Prosperitas is an open access journal [ISSN (International Standard Serial Number) 2064-759X (Print); ISSN 2786-4359 (Online); hereinafter referred to as "Prosperitas"/"Journal"] published by Budapest University of Economics and Business (seat: H-1055, Hungary, Budapest, Markó utca 29-31.; tax number: 19308722-2-41 and HU19308722; statistical code: 19308722-8542-563-01; institutional code: FI 82314; representative: Prof. Dr. György Andor, Rector) (hereinafter: "Publisher"). The Journal invites contributions in all fields of the subject area of Business, Management and Accounting linked to current problems and challenges facing businesses. Accordingly, Prosperitas publishes studies including, but not limited to, the following areas: management science, strategic management, business economics, finance, accounting, sustainability, corporate social responsibility, human resource management, organizational behaviour, organizational psychology, organizational governance, entrepreneurship, innovation, marketing, foreign and international trade, commerce, and hospitality.
